#### HELENA MONTANA KENNEL CLUB MEETING OF THE MEMBERSHIP

### **AUGUST 4, 2015**

Thea opened the meeting.

Peggy requested that she wanted her letter to go to the membership. It was explained that her letter and the letter from the Board had gone to the membership. Also that her letter which had been read into the record became a part of the minutes and was attached to the minutes. Carla called for a point of order to go on with the meeting.

Thea advised the membership that the budget at this time is looking good, we have extra income from the drop-ins. Classes, etc. and that we are \$ 3900.00 over the projected budget at this time. *Expenses:* We've spent no money on agility so far, however because of the AKC requirements for new jumps we are looking at vendors and it is looking like the new jumps will be around \$ 3,000 to 4,000. Just as soon as AKC makes the final decision we will then go out for final costs on the jumps. We have a need for updating the laptop and programs for the treasurer. The web site software also needs upgrading. We are looking at some web tools. The Great Falls club has fairly good web equipment.

Thea also advised that she updated the Home page on the web. She also updated the dates for training and that we would start a Young Peoples class in January. A beginners agility, Handling and equipment will be held in October. We also have a CGC workshop on August 15<sup>th</sup> with testing on August 22<sup>nd</sup>. Then another one in Oct-Nov.

We had a request from Carroll College to use our building for their dog class lab work. A check with Keith and the contract found that unless the fairgrounds could not meet the needs requested then we could consider the request. The Fairgrounds does have available spaces.

Alice wanted to know the difference between the 4-H program vs. the Young Peoples class. Deirdre wanted an example, a lengthy discussion was held.

We then had introduction of members and the guest.

AGILITY: Patty, Jeanine is doing a class that starts in November.

The trial: Patty advised that they will be calling for helpers. Set up will be on Thursday night at 6PM. We will need desserts and Wendy is hospitality chair for the trial. The premium is on the web site.

FALL CLUSTER SHOW: Barb advised that we need helpers, it takes a lot of man power. Set up will be Wednesday afternoon. Adele will be Chief Ring Steward. Raffle will be chaired by Monique and you can contact her as to where she wants the items.

Marion advised that the obedience ring rental will be on Friday night. Barb also advised that there will be two grooming spots for club members. Dick Vincent will be doing the parking again.

TRAINING COMMITTEE: We had a meeting and came up with a schedule for: Run thrus for the winter months.

Thea discussed the 4-H dog project and the young man who is working on some of the equipment and he needed matting. Thea sold him the matting for \$ 60.00, the training committee made the recommendation that the club donate back to the 4-H dog project \$ 100.00. Laurie E made a motion to approve of the donation, Rita seconded and all approved.

Rita said she had several issues to bring to the club. She had question about the budget for the year. Thea explained that the history and budget came to the membership at a meeting earlier in the year.

Rita had question about auditing the books and that was explained by the treasurer and president, several years they are audited by 3 members and then an audit is done by a CPA.

New Business designation was questioned and Jeanine explained what constitutes new business and Roberts Rules of Order protocol.

Thea requested that we have 2 or 3 members look at and research items for the web site.

Barb explained what Responsible Dog Days is and asked for someone to volunteer to take care of that for the Show. Nancy volunteered.

GRANTS: Chris advised that the application has been revised and on the web site.

Thea discussed the Fair Premium book and that the Kennel Club needs to be listed, she discussed this with Keith.
